- Tenders will be opened, before the attending tenderers or their authorized representatives who may wish to be present, in the office of the HOD(E&M), CMPDI, RI-3 at above mentioned time and date.
- Tender must be submitted, in sealed cover super-scribed with Tender number and due date of tender.
- The rate shall be quoted inclusive of all taxes and duties and FOR destination, Consignee's Store, at CMPDI-RI-III, Gondwana Place, Kanke Road Ranchi. The prices quoted must be firm till delivery. Lowest price in totality shall be criteria for considering L-1 bidder.
- Duly authenticated (should be signed by the authorized representative and sealed) copy of dealership certificate must be submitted along with the offer.
- Validity period of quotation shall be minimum 45 days from the date of opening of tender.
- Over-writing in the tender should be avoided. In case of any over-writing or alteration each over-writing or alteration shall be duly authenticated by tenderer with his/her signature and seal. In absence of such authentication tender shall be summarily rejected.

12. Supplied materials shall be inspected by the representative of the consignee at consignee's campus before final acceptance. In case the supplied item is found defective/ inadequate /not conforming to the order during inspection, material shall be replaced by the bidder at their cost and risk without extending any burden of any manner to the purchaser.
13. The material shall be supplied in original factory packaging condition.
14. Supply order, if placed will be governed by the prevailing Terms & Conditions of CMPDI/CIL.
15. The tenderer should enclose the brochure with specification of the items quoted by them along with the supplied material.
16. **Warranty-**
 - a) The inverter should carry warranty for a minimum period of 12 months from the date of supply of the material.
 - b) The tubular battery should carry warranty for a period of not less than 36 months (Min.) from the date of supply.
 - c) Duly filled warranty cards should accompany the supplied materials.
17. **Delivery:**
 - a) Tenderers are to supply the entire quantity and items of the order within a period of **30 (Thirty)** days from the date of receipt of Supply Order(s).
 - b) Material shall be supplied at Consignee's Store, at CMPDI-RI-III, Gondwana Place, Kanke Road Ranchi within the stipulated period specified above.
18. In the event of failure to supply within the stipulated date/period in accordance with the samples and/or specifications mentioned in the Supply Order and in the event of breach of any of the terms and conditions mentioned in the Supply Order, CMPDI, RI-III, has the right:
 - a) To recover from the successful tenderer, as liquidated damages a sum not less than 0.5% (half percent) of the price of any stores which the successful tenderer has not been able to supply as aforesaid for each week or part of a week during which the delivery of such material may be in arrears, limited to 10% (ten percent). However where felt necessary, the limit of 10% can be increased to 15% at the discretion of the competent authority of RI-III, CMPDI, Ranchi.
 - b) To purchase elsewhere, after due notice to the successful tenderer, on the account and at the risk of defaulting tenderer the material not supplied or others of a similar description without cancelling the supply order in respect of the consignment not yet due for supply, or-
 - c) To cancel the supply order or a portion thereof, and if so desired, to purchase the material at the risk and cost of the defaulting supplier and also –
 - d) To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty, if imposed shall not be more than the agreed Liquidated Damages referred to in Clause (a) above.
 - e) Whenever under the contract, a sum of money is recoverable from and payable by the supplier, CMPDI RI-III shall be entitled to recover such sum by appropriating in part or in whole, by deducting any sum or which at any time thereafter may become due to the successful tenderer in this or any other contract and should this sum be not sufficient to cover the full amount recoverable, the successful tenderer shall pay CMPDI RI-III on demand the remaining balance. The supplier shall not be entitled to any gain on any such purchase.
19. If the execution of the contract/supply order is delayed beyond the period stipulated in the contract/supply order as a result of outbreak of hostilities, declaration of an embargo or blockade, or fire, flood, acts of nature or any other contingency beyond the supplier's control, due to act of God, then CMPDI RI-III may allow such additional time by extending

the delivery period, as it considers to be justified by the circumstances of the case and its decision shall be final. If and when additional time is granted by CMPDI RI- III, the contract / supply order shall be read and understood as if it had contained from its inception the delivery date as extended.

20. Payment:

(i) 100% payment will be made within 21 days from the date of receipt and acceptance of the materials by the Consignee.

21. Overall lowest offer / lowest price in totality shall be criteria for considering L-1 offer. 22. Offers received after the submission time of the due date of the tender, will not be accepted.

23. CMPDI, RI-III shall not be responsible for non-receipt /delayed receipt of Tender Document.

24. All disputes are subject to the Court of Ranchi jurisdiction only.
