Part- 1 : In separate envelope, Part-I of the tender document as issued to the quotationer authenticated paper of credentials as per the eligibility criteria in the N.I.T. technical specifications, if any. **All the credentials/certificates related to technical qualifications should be duly attested/by the agency.**

Part- 2 : In separate envelope, Part- II of the tender document (Price bid) as issued to the quotationer **with all the pages signed by the quotationer. 4. THE ELIGIBILITY CRITERIA FOR THE WORK IS AS FOLLOWS:

- b) ~~Average annual financial turnover during last three years ending 31st March' 2019 should be at least 30% of estimated Amount.~~

~~The intending bidder must submit documentary evidence in support of above in the form of certificate from Chartered Accountant or audited balance sheet or suitable acceptable documents.~~

~~If any bidder does not submit the Turnover value for any of the 3 years, he will not disqualify instead shall consider all 3 years for computing the average by assuming a value of 'zero' for the year for which no information is given by bidder.~~

- c) Goods and Service Tax (Not Applicable for Exempted Goods/Services):

- 1. The quotationer should be either GST Registered Bidder/ Dealer or GST unregistered Bidder/ Dealer. The quotationer is liable to be registered under GST unless they are specifically exempt from registration under specific notification / circular / section / rule issued by statutory authorities. The bidder claiming exemption in this respect shall

submit supporting documents as well as certificate from Practicing CA/CMA/CS to the effect that quotationer is fulfilling all the conditions prescribed in notification to make him exempt from registration.

2. The item rate quoted by bidder shall be inclusive of all taxes, duties & levies but excluding GST & GST Compensation Cess, if applicable. The payment of GST and GST Compensation Cess by service availer (i.e. CMPDIL) to bidder/contractor (if GST payable by bidder/contractor) would be made only on the latter submitting a Bill/invoice in accordance with the provision of relevant GST Act and the rules made thereunder and after online filing of valid return on GST portal. Payment of GST & GST Compensation Cess is responsibility of bidder/contractor.

3. However, in case contractor is GST unregistered bidder/dealer in compliance with GST rules, the bidder/dealer shall not charge any GST and/or GST Compensation Cess on the bill/invoice.

- d) Photocopy of Permanent Account Number (PAN) card issued by Income Tax Deptt, Government of India
- e) Affidavit or any other document to prove proprietorship/ Individual status of the bidder / partnership firm with registered partnership deed / company with registration with memorandum & articles of association. Power of Attorney in case the tender is signed by an authorized representative of the tenderer.
- f) Copy of valid electrical license issued by Electrical Licensing Board/Authority of Maharashtra state or any other State Govt. /UT of India.
