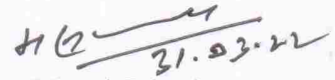

General Terms & conditions

The details of Terms & Conditions are as under :

1. This quotation document should be returned along with your quoted rates duly signed. The rates shall be quoted in figures as well as in words.
2. Photocopy of PAN (Permanent Income Tax Account No.) should be submitted.
3. The quoted rates shall be inclusive of labour charges, transportation charges (to and fro) etc all complete exclusive of GST.
4. Contract Period:- 12 months from the date of issue of work order.
5. The party shall make his own arrangement for the above work and maintain the desire quality of washing and deliver the clothes within 10 days after washing from the date of receipt.
6. The party will be responsible for any damage/loss of cloths during the works hence additional safety measure to be taken by the party for the safety of cloths.
7. The overall lowest bidder shall be considered for award of the work. Being lowest in any part of the quotation shall be of no consequence and such bidders shall not have any claim for award of part work.
8. Photocopy of **GSTIN**. If not registered, then declaration for unregistered bidder
9. Controlling Authority : GM(HRD), CMPDI (HQ), Ranchi.
10. Paying authority : GM(F), CMPDI (HQ), Ranchi.
11. The other terms and condition of the NIQ will be as per General Terms and Conditions (copy enclosed).
12. Payments shall be made through pre-receipted bill duly certified by engineer in-charge after acceptance of washed clothes.
13. Allowable variation for acceptance of quotations: After ascertaining the justified rate, the variation in award of work should generally be upto +10% of the justified rate. (As per Civil Manual Clause 4.17.1 Feb-2015)
14. All running on account bills shall be paid at 95% (ninety five percent) of work value. The balance 5% shall be treated as Retention Money and will be second part of security deposit.

Retention Money should be refunded after successful completion of contract.

15. Deviations /Variations in Quantities and Pricing :

The quantities given in the "Bill of Quantities" are based on estimates and are meant to indicate the extent of the work and to provide a uniform basis for tendering and any variation either by addition or omission shall not vitiate the contract.

15.1 The company through its Engineer-In-charge or his representative shall, without radically changing the original scope and nature of the work under the contract, have power to make any alterations in or additions to or substitution of the original specifications, and instructions that may appear to be necessary or advisable during the progress of the work.

The contractor shall be bound to carry out the works in accordance with the instructions given to him in writing by the Engineer-In-charge or his representative on behalf of the company. Such altered or additional or substituted work, which shall form part of the original contract, shall be carried out by the contractor on the same terms and conditions in all respects on which they agreed to do the main work and at the same rate/rates as are specified in the contract /work order.

15.2 The right is reserved to cancel any items of work included in the contract or portion thereof in any stage of execution if found necessary to the work and such omission shall not be a waiver of any condition of the contract nor invalidate any of the provisions thereof.

16. Termination/ cancellation of contract:-

16.1 The CMPDI shall, in addition to any remedial steps to be taken, be entitled to cancel/ terminate the contract in full or in part, if the contractor commits default/breach in complying with any of the terms and conditions of the contract and does not remedy it or fails to take effective steps for the remedy to the satisfaction of the engineer -in-charge.
