महोदय,

This has reference to LoA issued vide letter No.CMPDI/Geom/21/Drone Survey_UP/517 dated 07.06.2022. The present LoA supersedes the earlier LoA dated 07.06.2022, as mentioned above. CMPDI is pleased to give its intent for award of the work for Drone/UAV based Survey for generation of DTMs of Sand Mining Lease Areas in various Districts of Uttar Pradesh to M/s Aarav Unmanned System Pvt. Ltd on negotiated price of **Rs.54,900.00 per site (excluding 18% GST)**. The total value of the project shall depend upon actual number of sites surveyed.

1. Scope of work:

Drone/UAV based Survey for generation of DTMs of Sand Mining Lease areas in various Districts of Uttar Pradesh.

- DGPS Survey:** Dual Frequency Survey Grade DGPS System shall be used for establishing Ground Control Points.
- UAV/Drone Survey:** Survey grade Drone shall be used for carrying out the field survey of Sand Mine Lease Areas supplied by CMPDIL.
- Deployment of Manpower at CMPDI:** Minimum 2 nos. manpower shall be deployed for the duration of the project for a minimum duration of 45 days at CMPDI(HQ), Ranchi to provide support for data processing, data handling, Quality Control etc.

3. Terms and Conditions

- a) M/s Aarav Unmanned System Pvt. Ltd. (AUS) shall deploy sufficient no. of teams in parallel for data collection during Drone /UAV based field survey which shall be completed by 30.06.2022.
- b) The data submission of the acquired and generated data shall be by 31.07.2022.
- c) M/s Aarav Unmanned System Pvt. Ltd. (AUS) shall deploy minimum 2 nos. of support manpower at CMPDI(HQ) to provide support for data processing, data handling, Quality Control etc. for a minimum duration of 45 days at CMPDI(HQ), Ranchi. Expenses on logistics, accommodation etc. will be borne by AUS.
- d) The final billing shall be based on the actual no. of sites covered under Drone / UAV survey. If the site area is greater than 1.5 Sq. Kms, the same will be considered as two sites.
- e) **'Estimated Cost of Contract' and 'Cost of Contract':** The **Estimated cost of the contract** for the aforesaid work will be Rs.2,42,93,250.00 (Rupees Two Crore, Forty Two Lakhs, Ninety Three Thousand, Two Hundred and Fifty Five Only) including 18% GST based on the offered rate of **Rs.54,900.00 per site plus 18 % GST** (*The Estimated Cost of Contract has been calculated based on estimated 375 number sites and the offered cost of survey per site*). The final payable amount shall depend on the actual number of sites surveyed. After completion of the field survey, the **Cost of Contract** will be calculated based on actual number of sites surveyed.
- f) **Mobilisation Advance:** As per terms of offer from M/s Aarav Unmanned System, 25% of the estimated cost of contract i.e. Rs.60,73,313.00 (Rupees Sixty Lakhs, Seventy Three Thousand, Three Hundred & Thirteen Only) will be released as Mobilisation Advance only after submission of Performance Bank Guarantee (PBG) [proforma of PBG enclosed as Annexure-1] of Rs.66,80,644.00 (Rupees Sixty Six Lakhs, Eighty Thousand, Six Hundred & Forty Four Only) by M/s Aarav Unmanned System Pvt. Ltd. (AUS).

g) Period of completion: The field work for above UAV/Drone survey should be completed by 30.06.2022. Submission of District-wise Data and reports by 31.07.2022.

h) Permission / Exemption: M/s Aarav Unmanned Systems Pvt. Ltd. is responsible for obtaining all the requisite permissions from all the concerned authorities, before operation of the UAV. You are requested to execute the work strictly as per the required permissions. CMPDI will facilitate in obtaining the permissions / exemptions as required.

i) Responsibilities & Liabilities: Any damage done to any person/ property while operation of UAV, shall be the responsibility of M/s Aarav Unmanned Systems Pvt. Ltd. 'The Company' i.e. CMPDIL, shall not be in anyway bear any liability for damage of their UAV and accessories, if any.

j) Quality Assurance:

M/s Aarav Unmanned Systems Pvt. Ltd shall carry out and complete the work in all respect in accordance with the contract and shall ensure that the work conforms strictly to the instructions of the GM (Geomatics), CMPDI. GM (Geomatics), CMPDI may issue from time to time further detail instruction/directions in writing to the contractor. All such instruction/direction shall be consistent with the contract documents and should be reasonably inferable there from, along with clarification/explanations thereof, if necessary. Non fulfillment of any parameter/ condition as under table – 1 for any site, the site shall not be consider for payment.

k) Payment Terms:

1st installment

25% mobilization advance against PBG will be paid to M/s Aarav Unmanned Systems Pvt. Ltd. based on the **estimated cost of contract** (refer clause-e). This amount shall be paid against PBG equal to 110% of the mobilization advance submitted by M/s Aarav Unmanned Systems Pvt. Ltd.

2nd Installment

2nd installment shall be paid after completion of field survey. After completion of field survey, the total number of sites surveyed will be firm. The **cost of contract** (refer clause e) shall be calculated based on total number of site surveyed and offered rate per site including 18% GST.

25% of the cost of contract shall be paid as second installment.

Final Payment

Final payment will be made after successful completion of job and on the basis of final bill raised by M/s Aarav Unmanned Systems Pvt. Ltd. The final bill amount shall be calculated as follows,

Final payable amount = Cost of contract – (1st installment + 2nd installment)

The payment will be made within 21 days from the date of submission and acceptance of the soft and hard copies of desired outputs by GM (Geomatics) or his authorized representative. The bill should be submitted in triplicate to the General Manager (Geomatics), CMPDIL HQ, Ranchi for arranging payment. You are requested to confirm the details of your bank A/c No., Name and Address of the Bank and Branch Code for making the payment as per Mandate Form attached as Annexure-2.


m) **Extension in Date of Completion:** Extension of date of completion time is possible due to any force majeure.
