Notice for submission of Life Certificate for CPRMS-NE (Modified) & CPRMS-NE (2014)

This is in reference of CIL office memorandum no. CIL/C-5B/JBCCI/CPRMS-NE (Modified)/Life Certificate/348 dated 28.10.2022 regarding submission of Life Certificate for CPRMS-NE (Modified) & CPRMS-NE (2014).

In terms of clause 5.3 & 5.4 of the CPRMS-NE (Modified), eligible members of the scheme shall need to submit copy of the life-certificate in the month of November each year w.e.f. November 2022 onwards, either by Physical means at appropriate office or by online mode.

In reference to online submission of Life Certificate, it is pertinent to mention that as the Jeevan Pramaan Portal is primarily for submission of Life Certificate for the purpose of pension, incorrect submission on the portal may lead to discontinuation of pension under CMPS-1998 from CMPFO as noted from various grievances received in past.

Accordingly, eligible members of CPRMS-NE [CPRMS-NE) Modified as well as CPRMS-NE (2014)] are hereby requested for submission of online Life Certificate if willing to submit through Jeevan Pramaan Portal of Government of India. While using the portal, such members must be careful and select "COAL INDIA LIMITED" while submitting Life Certificate for CPRMS-NE against each of the three heads viz. "Disbursing Authority" & "Agency" in the fields on the portal.

In other words, for online submission, separated employees who are registered beneficiaries for CPRMS-NE and CMPS-1998, must submit separate Life Certificate each time through Jeevan Pramaan Portal for CPRMSNE benefits from CIL/Subsidiaries and for CMPS-1998 from CMPFO by selecting Appropriate Authorities against each of the above three viz. Disbursing Authority, Sanctioning Authority and Agency.

The above is also applicable to the eligible members of CPRMS-NE (2014). Further. It may be noted that the non-submission of "Life-Certificate" will make the Medical Card(s) invalid for availing benefits under CPRMS-NE.

In view of above, all members of CPRMS-NE (Modified) & CPRMS-NE (2014) are requested to submit the "Life Certificate" in the month of November, 2022.

In continuation to the Office Memorandum No.: CIL/C-5B/JBCCI/CPRMS-NE/216 dated: 18.11.2021 on the subject mentioned above (copy enclosed), this is to inform that in terms of Clause 5.3 & 5.4 of the CPRMS-NE (Modified), eligible members of the scheme shall need to submit copy of the life-certificate in the month of November each year w.e.f. November 2022 onwards, either by physical means at appropriate office or by online mode.

In reference to online submission of Life Certificate, it is pertinent to mention that as the Jeevan Pramaan Portal is primarily for submission of Life Certificate for the purpose of pension, incorrect submission on the portal may lead to discontinuation of pension under CMPS-1998 from CMPFO as noted from various grievances received in the past.

Accordingly, eligible members of CPRMS-NE [CPRMS-NE (Modified) as well as CPRMS-NE (2014)] must be sensitized regarding submission of online Life Certificate if willing to submit through Jeevan Pramaan Portal of Government of India. While using the portal, such members must be careful and select "COAL INDIA LIMITED" while submitting Life Certificate for CPRMSNE against each of the three heads viz. "Disbursing Authority", "Sanctioning Authority" & "Agency" in the fields on the portal.

विषय: Amendment in CPRMS-NE (Modified)

In terms of the resolution signed after deliberation held in the 2nd meeting of Board of Trustees of CPRMS-NE (Modified) Trust held on 24.08.2021, following decisions have been taken:

1. The following shall be included under Clause 2.0/2.1; "Eligibility/Persons Covered under the scheme": -

"Who have separated under Retirement Before Superannuation Scheme for Non-Executives of CIL & Subsidiaries"

2. Following shall be added to the Clause 2.1 i) of the Scheme:

"Members of CPRMS-NE (2014) who have paid Rs. 40,000 as membership contribution shall automatically become member of the CPRMS-NE (Modified)"

For such members of CPRMS-NE (2014) who become member of CPRMS-NE (Modified), as per Clause 5.2 of the scheme, a separate Medical card under CPRMS-NE (Modified) shall be issued only after depositing the card issued under CPRMS-NE (2014).

3. It has been decided to insert/amend following clauses in the CPRMS-NE (Modified):

- I. 3.1.2 a) iii) shall be inserted as under: -

"Hospitals/Dispensaries of CIL/Subsidiaries"

- II. For the purpose of bringing uniformity in submission of life cover scheme as done in case of CMPS-1998 & CPRMSE, "December" in Clause 5.4 of the scheme shall be substituted with "November". It shall be effective from November 2022 onwards.

Endeavour shall be made to digitalize the submission of Life Certificate by linking it to Jeevan Pramaan Portal of the Govt. of India.

All concerned are requested to take necessary action accordingly.
