3.0 The proposal of Vigilance department regarding addition of proposed posts/jobs to the list of sensitive posts in respect of CMPDI in accordance with the CIL's OM dated 15.11.13 and in the light of the directives of the Central Vigilance Commission, New Delhi, vide circular no. 22/10/22 dated 25.10.2022, was discussed.
