Advisory

Sub: Anomalies observed during file scrutiny related to procurement of goods in GeM portal.

During the scrutiny of files related to procurement of goods in GeM portal by Vigilance Department, it was observed that single and known party participated in the bidding process from which quotation was sought for preparation of estimate. The specification prepared by the technical department was same as that of the party from which quotation was sought.

2. Declaration as per Clause 13.15.14 of Purchase Manual, 2020 was not included and signed by TC members in the TC deliberation. This is also mandatory as per CVC Office Order No. 71/12/5 dated 09.12.2005 and Clause 9.16.5 (a) of Vigilance Manual, 2021.

3. Following advisories are issued in this regard:

- i. The specification should be based on need based technical requirement and it should not be tailored made to suit a particular make/brand.
- ii. Rate reasonability was not discussed in TC proceedings and just because the L1 rate is less than the estimate does not mean that the rates are reasonable. All attempts should be made to compare with last accepted rate where supplies have been satisfactorily completed wherever applicable.
- iii. The estimate and framing of technical specification should be based on budgetary offers from at least three vendors for different makes of equipment. In case proven LARs are available, the same may also be considered for purpose of estimation.
- iv. The cases where only particular make is required, their Proprietary Article Certificate (PAC) must be accompanied with indents. However, advertised tendering may be preferred to explore the possibility of equivalent substitute. It is clarified that technical tailor made specification is no substitute for PAC.
