Sub: Additional Performance Security Deposit.

1. It has come to the notice that proposal for inclusion of Additional Performance Security Deposit (APSD) Clause in the approved model NIT for all the civil e-tender works contracts came up for discussion in Functional Directors' Meeting. In this regard, following are the remarks of the undersigned in the matter of Additional Performance Security Deposit:

- i. APSD is required for the contracts when the contract is awarded 15% below the estimated value of tender. The main reason for taking APSD is to protect the interest of the company arising out of apprehensions of failure of contract, compromise in quality of work and other problems inherent with award of contract at abnormally low rate.
- ii. **The APSD Clause is not an enabling provision to award contract at abnormally low rate.** The contract is to be awarded only after the Tender Committee and Accepting Authority is convinced that the price offered by the lowest technically suitable bidder is reasonable for the performance of the contract. However, in case the contract is awarded at 15% below the estimated value when the tender Accepting Authority is convinced regarding the performance of contract, the issue of APSD comes in picture to set off the institutional apprehensions regarding the performance of contract as per the scope of work, quality and timelines to protect the interest of the company in case of breach of contract which obviously has financial implications.
- iii. In case the lowest technically suitable offer is seriously unbalanced at abnormally low price, then the detailed price analysis for any or all items of Bill of Quantities is to be taken from the bidder to demonstrate the internal consistency of these prices with the construction method and schedule proposed. Only after this, if the Tender Committee is convinced that the bidder can perform the contract at the offered rate, the tender is awarded to the bidder. It is clarified that the APSD is the tender condition to form the part of contract in case the contract is awarded below 15% of the estimated value and in no way, it is an enabling provision for award



2. Hence, it is strongly advised that while including the APSD Clause in NIT document, it may be informed to all the Officers of CMPDI dealing with tender that APSD is the terms and conditions of contract and not an enabling provision for award of contract at abnormally low that is unreasonable for performance of the contract. The work is to be awarded if the TC and TAA is convinced by doing price analysis that the low price offered by the bidder is reasonable for performance of contract.
