Shri Rajeev Kumar Sinha assumed charge as Director (Technical), CMPDI



Senior officials from CMPDI served as jury members and evaluated the solutions proposed by participating teams.



CMPDI at Smart India Hackathon (SIH) 2025 – Hardware Edition

CMPDI represented the Ministry of Coal at the Smart India Hackathon (SIH) 2025, Hardware Edition, held at Sri Sai Ram Engineering College, Chennai, from 8–12 December 2025.

CMPDI officials served as the Jury for Problem Statement SIH25182: "Smart PPE Compliance Monitoring and Reporting System for Underground Coal Mine Workers." A total of 118 teams submitted solutions, and after rigorous evaluation, two teams were declared joint winners for their exceptional performance in innovation, feasibility, scalability, and potential impact on worker safety.





CMPDI conducted drone-based topographical surveys at Shaktigarh UG, WCL

On 11.11.2025, CMPDI conducted drone-based topographical surveys at Shaktigarh UG, WCL to generate highly accurate topographical contours. This data is a crucial input for geological modelling and subsequently, for preparation of Project Report (PR) and Geological Report (GR).



Administration at Your Door

On 19.11.2025, CMPDI, RI-IV, Nagpur, conducted a visit to the Durgapur camp and its drill sites as part of the "Administration at Your Door" campaign to address employee grievances. The initiative facilitated direct interaction between RI-IV officials and employees working in remote locations, strengthening communication between staff and management.



Assessment of Mine Inclines for Safe Operations

CMPDI, RI-IV, Nagpur, Western Coalfields Limited (WCL), and Tawa Mine-III, WCL jointly conducted a detailed inspection of Inclines No. 1 and 2 of WCL. During the visit, the team recorded on-site observations, captured photographs, collected geological samples, and analyzed the strata conditions along with associated faults. The findings from this inspection have been compiled into a joint report to support WCL in ensuring safe and efficient mine operations.

CMPDI Leverages Advanced Drone Technology for Final Stock Measurement

On 29.11.2025, CMPDI carried out Coal stock measurement at IB Valley area, Mahanadi Coalfields Limited (MCL), using drones equipped with five-angle oblique cameras. This marks a significant technological upgrade over traditional survey methods, enabling high-resolution, multi-view 3D reconstruction of coal piles.



OSD to CMD, CMPDI Reviewed Sonepur Bazari Project, ECL


Workshop on Artificial Intelligence (AI) for Finance Executives
