1. The policy for e-auctioning of coal through a single window mode agnostic offer has been introduced in terms of Ministry of Coal guidelines circulated vide letter no. CPD-23011/18/2021-CPD dated 21.03.2022 on approval from Cabinet Committee of Economic Affairs (CCEA).
2. Clause 7.6 of above e auction scheme is reproduced below:-

#### Quote :-

7.6 *Although loading will be the responsibility of the Coal Company, but to avoid any complaint regarding over-loading, under loading and quality, the Buyer himself or his authorized representative may supervise loading at the loading point. The authorized representative must carry valid authority letter along with photocopy of Identity Card issued by Service Provider.*

#### Unquote :-

As per clause 7.6 of the CIL eAuction scheme, authorized representatives must carry a valid authority letter and a photocopy of the Identity Card issued by the Service Provider to supervise loading at the loading point.

Therefore in compliance to the above, all the consumers are hereby notified that above shall be mandatory to supervise loading at the loading point effective from all future auctions of NEC. No authorisation shall be issued in absence of the above two documents. This was also agreed upon by Coal consumers in the meeting dated 06.09.2024 at Tikak Colliery.



In continuation to the earlier notice No.NEC/M&S/61/ dated 10.09.2024 issued by this office regarding implementation of clause 7.6 for authorisation of representative, all the buyers are hereby notified that compliance of clause 11.4 and 11.15 of CIL auction scheme introduced in terms of Ministry of Coal guidelines circulated vide letter no. CPD-23011/18/2021-CPD dated 21.03.2022 on approval from Cabinet Committee of Economic Affairs (CCEA) is mandatory with immediate effect and same is reproduced below:-

#### Quote :-

11.14 The buyer shall be responsible for compliance of e-way bill for which the required information shall be provided by the respective coal company.

11.15 Compliance of all laws/rules/regulation by any authority shall be responsibility of Buyer and coal company/CIL shall remain fully indemnified in this regard under any circumstances.

#### Unquote :-

As per clause 11.14 of CIL auction scheme the buyers shall be responsible for compliance of e-way bill (a government mechanism already in place for tracking movement of goods) for transportation of coal purchased from NEC for which the required information are regularly provided by NEC in the form of tax invoice and road challan which are the two documents to prove the legal purchase of Coal from NEC. As per clause 11.15 of CIL auction scheme, compliance of all laws/rules/regulation by any authority for transportation of Coal purchased from NEC/CIL shall be the full responsibility of Buyers and not NEC/CIL. NEC/CIL shall remain fully indemnified in this regard under any circumstances.

Therefore all the buyers are hereby notified to comply with the above with immediate effect.
